For over three decades we have been able to help animals in need and during that time our work has been aided by your compassionate support. Peace. Freedom. Protection. These are what your gifts make possible for the gentle equines in the Sanctuary. Thank you for caring so very much.

2022: A challenging year

2022 was a year of challenges for everyone and it was no different at The Donkey Sanctuary of Canada (DSC). As the months passed, we took small steps away from the burdens of Covid, but we were made aware partway through that some changes in our way of doing things had limited our communications with members. After a period of readjustment, at the Board and the Staff levels, 2023 has seen a resurgence of the connectedness that characterized the DSC community in years previous.

Animal care

Animal care at the DSC has always aimed to be of the highest standard. Last year was no exception thanks to our dedicated animal health and training staff. They monitor and attend to the donkeys and mules 24/7 with the results being evident in our herds of healthy, contented residents. At the year's end, 103 donkeys and mules were receiving care. Over the year a record number of foals were born on site: 2 jacks and a jenny, Pekoe, Caesar, and Gwyn. Their high energy and playfulness are a delight to see even though their mothers do tire of it at times! They are all doing very well.

Foster Farm Program

While those admissions were taking place, there was considerable movement in the DSC Foster Farm Program. 8 donkeys were placed at farms where they will receive much personal attention. In turn, 13 donkeys from DSC Foster Farms were brought back to the Sanctuary. Donkeys are placed "on permanent loan" at our Foster Farms and no matter the reason, if a point comes when they can no longer reside there then the animals return to the DSC. This policy is part of our commitment to their lifelong care.

Education

The Education Program is a component part of the DSC Mission. Through our tours and Open Days, we reach out to the general public to inform them about issues in humane animal care and animal welfare. Articles in publications and education brochures extend our reach, as does the Gelding Awareness and Support Program. Overall, 233 donkey and mule owners were aided by our donkey care and consultation services in 2022.

A generous gift

Early in 2022 a generous bequest was made to the Sanctuary which had a major impact upon the facility. Estate gifts help us to plan for future years and this one made possible the construction of both a Training Center/ Mule House, and an extension to the Donkey House. The impact of these new areas has enhanced daily operations, and we are grateful to this far-sighted donor, a member of our Green Fields Circle, for this lasting gift.

Our volunteers

Volunteers have always been at the heart of DSC life. As Covid restrictions receded we were able to welcome volunteers back to the Sanctuary where they could once again assist with animal care, facility maintenance, office work, Open Days, and special events. Their enthusiasm is infectious whenever they are on site and their combined efforts are exceptional.

Administrative support

The dedicated efforts of the DSC administrative staff are integral to our work as well. They attend to countless matters which must be addressed for the Sanctuary to operate on a dayto-day basis: hosting events, raising much-needed funds, welcoming visitors, and liaising with our supporters. Altogether, the community that is The Donkey Sanctuary of Canada is in good hands.




